# Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

15x Tilia europaea, 4x Cedrus atlantica, and 1x Betula pendula along the south side of Woodchurch Road.

T1 Cedrus atlantica as identified on the attached plan -

The central leading stem is absent. The south facing upper branch has assumed dominance as the new leading stem and upper canopy. Approximately 2m from the branch union, the stem dog-legs to grow vertically, with reaction wood evident at the branch union. There is possible decay at the branch union, associated with the branch shed wound from the absent central stem. This branch currently supports the union of the upper stem.

The structural integrity of the branch union maybe compromised due to possible decay and the additional loading of the displaced canopy. This presents an increased risk of partial canopy failure, particularly under wind loading.

Recommend -

Reduce the height of the south facing leading stem by 4-5m to alleviate weight stress on the branch union.

Crown lift to 5.2m above ground level on the roadside aspect only, to achieve statutory highway clearance.

Crown clean by removal of dead, dying, or diseased branches.

All trees included within this application contain visible deadwood exceeding 70mm in diameter. In addition, lower branches encroach into the required 5.2m highway clearance. This presents a risk of deadwood onto the highway and of branches obstructing high-sided vehicles.

All 21 trees including T1 will be crown-lifted to provide a clearance 5.2m above ground level on the roadside aspect only, to achieve statutory highway clearance. With crown cleaning and removal of dead, dying, or diseased branches.

All works will be carried out in accordance with BS 3998:2010 'tree work recommendations'

## Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
