An update was provided on the work undertaken by Cllr Jones, Cllr Jablonskas and Cllr Gardiner. 2 quotes have been received and a third is awaited. GBC have granted permission for a Noticeboard to be installed on Bewcastle Road near the post box. NCC/viaem have agreed in principle for a Noticeboard to be installed at the junction of Bewcastle Road and Muirfield Road near Benedict Court and have requested information of how the board will be installed. A fully costed proposal with landlord permissions will be brought to the May meeting for approval. b) Equality and Diversity Policy. A draft has been circulated between Cllrs Jones, Jablonskas and Gardiner for consideration and amendment. It is intended to bring a draft to the May meeting for approval and adoption.

Cllr Ellis said that Gedling Play Forum will be attending WAG's Muirfield Family Fun Jumble on Sunday 4th May providing a range of activities for all ages. Bestwood Village are organising a Community Orchard Gardening event on 10th May, all welcome Cllr Ellis is organising with the Bestwood Village Yarnarchists group production of a poppy cascade to be installed at St Marks Church in time for Remembrance Day 2025 and invites others to get involved. Emmanuel Church is organising a VE Day Community Afternoon Tea on Monday 5th May 2025 2pm to 4pm. No charge - donations welcome. Community Governance Review closes on 2nd May 2025. b) Cllr Boultby reported that he had spoken to a parishioner living on Pavilion Road who raised the problems caused by the Parking on NG5 FC match days when she can't even use her own driveway. When she has made approaches she said she has been threatened and abused. Cllr Boultby wondered whether the Council could take this issue up with NG5 FC on behalf of parishioners. Cllr Ellis agreed
681/25	CPR training: to meet the cost of hall renting	Cllr Jones joined the meeting at 7.17pm. Cllr Ellis made reference to a recent incident at Moor Bridge where a member of the public was able to perform CPR. Cllr Ellis previously organised CPR training sessions and the Council funded the rental of the Church Hall for this purpose. She is asking the Council to fund the rental of the Church Hall for another training session for 18 participants. EMAS provide the training and do not charge for this. In addition to CPR the training also covers use of Defibrillators. The proposal was supported and it was agreed that places should be allocated to parishioners first and any remaining places then offered to people from outside the parish.
